REQUIREMENTS FOR THE COURSE

1. There will be two exams through the course of the semester. Two midterm exams will be of the same length and will cover approximately half of the material. The midterm exams will not be comprehensive. The final exam will be comprehensive. The exams will be challenging and will require independent thought. The exams will be a mixture of multiple choice and essay questions.
2. Extra reading in the form of assigned journal, newspaper, or web articles will be given and will be used for two discussion classes during the course of the semester. The assigned reading will be given one week ahead of time. Students will be required to read the article, turn in a brief and accurate summary of the article, and participate in the classroom discussion for full credit. Exam questions may also come from the reading and class discussion.
3. A research paper on a topic of interest to you is also required. Since the paper is a major part of your grade it should be no less than 8 pages (excluding bibliography) and no more than 15 pages. Of course, the topic must be in the general area of health economics. The paper must be done with at least one other student in the course and no more than two other students. The paper will be a synthesis of research already done on a particular topic. A paper of this type should include an introduction explaining why the topic is of interest and identifying the main points to be covered; the main body which reviews research in the area and synthesizes the research; and a conclusion which summarizes the final results of the research and suggests the direction needed for future research. An outline of the paper will be required.

Since the paper is a large project it is important that you begin it early in the semester.

4. The grading for the course will be as follows:

There will be opportunity for extra credit on all of the exams. Letter grades will be assigned based upon the total points and the best judgment of the instructor. **I will use the +/- grading system.** Students will be informed of their current grade after each assignment.
